Penalties

Regarding N.S.F. cheques or Cancellation of cheques for any entry, a member may be suspended and denied privileges as stated in the OQHA Official Handbook. Buy in options for eligibility - \$200 paid by Dec.31st of Weanling year, \$300 paid by Dec.31st of Yearling year, \$500 paid by Dec. 31st of the 2 year old year and \$800 paid by June 1st of the 3 year old year, plus current year entry fees.

Transfers

A transfer fee of \$10.00 is to be made to the Secretary upon change of ownership. The buyer is to be responsible for supplying the transfer in order that the Futurity knows the location of all foals eligible.

Liability

No entry is liable for more than the amount paid in, but there will be no return of a payment unless the showing of the Futurity is called off in any or all divisions. The right is reserved to reject any entry and to debar any entry from competitions for failure to comply with the conditions of the Futurity.
